STATUTES OF ZLATÝ AMPER 2024 COMPETITION

Article 1

ANNOUNCER OF THE COMPETITION, DEADLINES

1.1 TERINVEST, s.r.o. announces the ZLATÝ AMPER 2024 (GOLDEN AMPER 2024) competition on the occasion of the 30th International Trade Fair of Electrotechnics, Energetics, Automation, Communication, Lighting and Security Technologies, AMPER 2024. ZLATÝ AMPER 2024 is a competition for the best product presented at AMPER 2024 trade fair.

1.2 The competition and the evaluation are held during the AMPER 2024 Trade Fair. The deadline for registration to the competition is 12. 2. 2024; later registered exhibits will not be taken into account.

Article 2

CONDITIONS OF THE COMPETITION

2.1 The competition is intended only for exhibitors of the AMPER 2024 trade fair, who participate in it on paid exhibition space of at least 9 m² and who properly fill out the application for the ZLATÝ AMPER 2024 competition and pay the registration fee EUR 200.

2.2 The quantity of products registered into the competition is not limited. Each product has to be registered by separate registration.

2.3 Products that were honoured by other awards can be also registered for ZLATÝ AMPER 2024 competition. Each product can be honoured by the ZLATÝ AMPER Award only once.

2.4 The competitor is obliged to arrange the professional demonstration of the product to committee members during the first day of the trade fair.

Article 3

EVALUATION CRITERIA OF COMPETITIVE EXHIBITS

3.1 The basic evaluation criteria are following:

- technical and technological level following present trends and progressive development in the field
- original solution, creative contribution of manufacturer (invention, patent)
- product safety (respecting law no. 22/1997 Coll. as amended) documented by certificates and statement of conformity
- business technical quality, guaranty of legislative conditions for sale, fly sheets, price level, supply possibilities, services, etc.

3.2 Registered exhibit will not be assessed in case of the following:

- exhibitor does not fill registration form properly, even after being requested by the organizer
- exhibitor does not provides to the commission data and information sufficient to assess compliance with competition criteria
- exhibitor withdraws from the competition after the deadline
- the exhibitor does not pay the price for exhibition space at the AMPER 2024 fair by the due date
- exhibitor cancels his participation in the AMPER trade fair

3.3 In the case of Section 3.2. exhibitor is not entitled for the registration fee refund.

Article 4

THE EVALUATION PROCES OF COMPETITIVE EXHIBITS

4.1 Products are evaluated by professional committee members from the fields of electrical engineering and electronics. The committee members will be specified at the start of the fair.

4.2 Committee members will judge products regarding to the filled out order form for participation in the competition, information materials delivered by the competitor (pictures, photos, technical articles, previous awards, etc.) and demonstration of the product to committee members during the first day of the trade fair.

4.3 The competitor is fully responsible for the accuracy and legitimacy of materials delivered to committee members and is not entitled to rely on other content or materials than submitted to the commission.

4.4 Committee members have the right to require additional information; for the assessment and conclusions, however, can use other credible and trusted sources.

4.5 Up to 5 exhibits will be awarded without ranking.

4.6 In case that different exhibitors will register the same exhibit, one award can be granted to all this exhibitors.

4.7 Committee members can award other unique products by Honourable mention.

4.8 Competition organizer is not obliged to give reasons for the committee members' decision; evaluation process is not public. An appeal against the commission decision is not possible.

Article 5

AWARD, CEREMONY

5.1 Awards will be announced and presented at a gala ceremony by competition organizer and chairman of the evaluation committee during the trade fair.

5.2 Awarded exhibits will be published in a Press release and a Final Report of the trade fair and through specialized media.

5.3 By properly completing the application form gives the applicant to TERINVEST Company in accordance with the provisions of Act No. 121/2000 Coll. on copyright, rights related to copyright and amending certain laws (the Copyright Act), as amended, permission to use the information provided (information about registered exhibit, photos, videos) for marketing purposes.

5.4 An exhibitor who receives the „ZLATÝ AMPER“ award is entitled to use the award for other promotional purposes, in this regard, he is entitled to use the logo of AMPER 2024 Trade Fair.

Article 6

CANCELLATION OF THE COMPETITION

6.1 The competition organizer reserves the right to cancel the competition under the conditions stipulated by law.
